- b. Must not have been expelled from school within the last 12 months.
- c. Must not have caused physical injury to a student, school employee, or visitor to the school.
- d. Must not have violated the school's drug or alcohol rules.
- e. Acceptance of tuition students is for one school year only, to continue attendance at RFCSC, students need to apply annually.
- f. Must not have been in possession of a firearm, deadly weapon, or destructive device.  
IC 20-33-8-6.
- g. Must not be transferring for the primary purpose of athletic reasons.
- h. The district will review student discipline history for 2017-18 school year.
- i. The deadline to return continued tuition applications for the 2018-19 school year is Friday, May 4, 2018.
- j. Parents are required to provide transportation for tuition student(s).
- k. It is a RFCSC expectation that students will follow attendance and tardy guidelines.
- l. It is a RFCSC expectation that students behave in a manner consistent with that which is outlined in school handbook.
- m. **All outstanding debts including tuition, book rental, and class fees must be paid before your student will be considered for continued enrollment.**

Total amount of Tuition for the school year is \$100 for the first student and \$25 for each additional student in the family enrolled. **\$25 deposit for each student is due at the time of application.**
